John asked councilors to continue to raise up staff for the amazing work and support staff, particularly as we go into strategic planning - as we head into a somewhat normal year.

### **Approval of June 8, 2023 Council Meeting Minutes**

# **Executive Director's Report (Skerritt-Davis)**

Steven expressed pride in the team, coming off a banner year with once-in-a-lifetime funding, for developing a plan and distributing additional funds in an equitable, consistent manner within a 12-month period. He's encouraging



staff to take the time now to recharge and to take lessons learned about working collaboratively and smarter with us as we return to our normal budget He acknowledged that with the new administration, we are seeing shifting priorities, new councilors, and new energy, and he expressed excitement about engaging with new councilors on how we provide access to the arts for all Marylanders. He added that the strategic plan implementation has been very successful, particularly in reaching new constituencies. We are continuing that work, and this feels like a great time to go into strategic planning Steven reviewed the organizational chart including a new reporting structure (directly to the Deputy Secretary) and Chad's promotion to Deputy Director. Steven acknowledged Grace Cavelieri's tireless work as Poet Laureate and the process is underway for selecting the State's 11th poet laureate. He also reported that Chad is finalizing the FY23 annual report; Commerce's most recent Office of Legislative Affairs audit revealed a few findings that will have minor impacts on programs and processes; the FY25 capital and agency request budgets have been submitted.

#### **Staff Reports**

Ryan Patterson gave updates on the Arts Capital grant program development; Steven led a review of the demand for MSAC's programs and staffing capacity challenges.

### **Executive Committee Report**

John led the councilors in a discussion about legislative earmarks and various options to align with other state arts agencies and create policies that take line items into account when making grants through MSAC programs Albita made a motion to move forward making line items unallowable income for the purposes of calculating Grants for Organizations grant amounts and to address concerns with the Preservation of Cultural Arts Fund with Maryland Citizens for the Art. John seconded the motion.

All in favor, the motion passed.

Delegate Pasteur abstained.
